KEY TERMS

Event

Events either begin or end a child's placement in a foster care setting; therefore, an event can either be a **placement event** or an **exit event**.

Entries into foster care are placement events because they represent the child's first placement upon entering care. Placement moves are also placement events because they represent the beginning of a new placement.

Discharges from foster care are exit events because they represent the end of a foster care spell.

Spell

A **spell** is a continuous period of time that a child spends in foster care. A placement event starts a spell; an exit event ends a spell. A child can have more than one spell in foster care; this is the case when a child re-enters foster care after a prior discharge. In this database, the following rules apply to the definition of a foster care spell:

- All spells are retained regardless of duration.
- There is no bridging of spells.
- Spells are only included if the child's age at the beginning of the spell is between 0 and less than or equal to 17 for first spells.
- For reentries, spells are only included if the child's age is between 0 and 20.
- Spells are forced to exit to reach majority (XRM) at when a child reaches age 21.
- If a spell shows an exit to runaway (XRY) and the child's age at exit is less than 0, the exit code is changed to "other" (XOT).
- If a spell shows an exit to reach majority (XRM) and the child's age at exit is less than 13, the exit code is changed to "other" (XOT).

Censor date

The **censor date** is the calendar day as of which the database is updated. Therefore, a child's experience in foster care can only be observed as of the censor date.

Censored spells When a child placed in foster care is still in care as of the censor date, the child's placement history is incomplete. In this situation, we say that the spell is **censored**.

For example, assume that the censor date is December 31, 2011. If a child enters foster care on January 1, 2011 and exits care on June 30, 2011, we can determine that the length of that child's foster care spell was six months. However, if a child who entered care on January 1, 2011 was still in care on December 31, 2011—the censor date—we cannot determine the child's length of stay because we do not yet know whether or when after December 31, 2011 the child exited foster care.

VARIABLE NAMES AND CODES

The **All Spells** page of the web tool allows you to pull up the foster care spell records that comprise the database off of which the automated analyses are run. The records contain a number of variables pertaining to the child and his/her experience in foster care.

Clicking **List Records** produces the spell records that match your selection criteria in your browser at the bottom of the All Spells page. The List Records function displays a maximum of 500 records. Clicking **Download Data** produces a .csv file containing all of the spell records that match your selection criteria.

The table below shows the variable name as it appears in the List Records output, the variable name as it appears in the Download Data output, the definition of the variable, and the way in which the variable is coded (if applicable).
