Section 1: Profile Page

LIS Unique ID
for the individual searched

Type of Clearance
- Types depend on ORI number
- Examples: Licensing, Trustline

Status: Active/Active Not Working/Inactive/Closed
Profiles become inactive when not working for 2 years.
