



Reformatted Vignette Matrix	Definition location in the SDM manual	SDM tools already completed	
The Vignette Matrix is now four pages so all pertinent activity information appears on the same page. Trainers should reference this matrix throughout the activity.	Write up on white board: Safety Assessment pg. 37. (P&P), Risk Assessment pg. 74, FSNA pg.95, Re-assessment 150, Risk-reassessment 134.	During the activity, some trainees have reported that the decisions have already been made and what was the point of having them read through the tools Explain that the SDM tools are already completed for two main reasons: to allow time for content and concept development versus spending time penciling in the form as well as to ensure the tools are being completed accurately by all trainees as this is a skills lab.	

Shapes were added to the center of the cover page of each vignette. Please note that each shape pertains to a vignette activity listed on the vignette matrix and assigned to a table group.
