ALL COUNTY LETTER (ACL) NO. 18-73, DATED JUNE 14, 2018

This letter informs counties of the Fiscal Year 2018-19 allocation for the Emergency Child Care Bridge Program for Foster Children (Bridge Program). A total of \$30.9 million General Fund (GF) is available based on the Budget Act of 2018. An amount of \$500,000 GF was held back to fund a contract with the California Child Care Resource and Referral (R&R) Network to develop and coordinate the training content used by participating local Child Care R&R programs. The remaining \$30.4 million GF is available for distribution.

The Bridge Program is comprised of three main components: the emergency child care vouchers, child care navigator, and trauma-informed care training. Funds were distributed for these three components in the following manner:

- Emergency child care voucher \$22.0 million GF
- Child care navigator \$4.5 million GF
- Trauma-informed care training \$3.9 million GF

Emergency Child Care Voucher - Assistance

A total of \$22.0 million GF for emergency child care vouchers was distributed using each county's percentage of the total statewide allocation based on eligible caseload multiplied by the Regional Market Rate for the appropriate category (Infant, Preschool and School Age). The caseload reflects children ages zero to twelve in relative, nonrelative extended family member, and foster family home and foster family agency placements, including those placements approved as Resource Families based on data from the California Child Welfare Indicators Project as of January 1, 2018. A minimum floor based on caseload size categories was incorporated to ensure counties receive no less than the following minimum allocations:

Very small: \$10,000Small: \$20,000Medium: \$50,000Large: \$100,000

The amounts originally allocated in <u>ACL No. 18-73</u> to counties that did not opt into the Bridge Program for the emergency child care voucher component were redistributed to participating counties based on each county's percentage of the total original allocation for participating counties.

Child Care Navigator and Trauma-Informed Care Training – Administration

The \$4.5 million GF for the child care navigator component was distributed based on each county's number of local participating Child Care R&R programs and its percentage of the statewide total eligible caseload, as described above. The \$3.9 million GF for trauma-informed care training was distributed based on each county's percentage of the statewide total eligible caseload. A minimum floor was incorporated to ensure that counties receive an allocation no less than \$17,500 for the child care navigator and \$1,000 for trauma-informed care training components.

The GF held back for contracted activities mentioned above was drawn from the child care navigator and trauma-informed care training allocations of counties that did not opt into the Bridge Program. The remaining GF of non-opt in counties was redistributed to participating counties based on each county's percentage of the total original allocation for participating counties.
