



Everything You Ever Wanted to Know About Juvenile Probation

This introductory, three day class is designed to help provide training to CDSS staff around the topic and issues of Juvenile Probation. The differences in the Juvenile Delinquency versus Dependency court systems, and a brief overview of how and why children are sometimes subject to adult court procedures.

Participants will be able to:

- **Define** – The purpose of various delinquency court hearings
- **Identify** basic legal issues related to Probation Youth including:
 - Basic elements of Division 31 regulations
 - WIC 241.1 & Dual Jurisdiction
 - Elements of Juvenile Delinquency Courts
 - Judicial orders and Title IV-E funding
 - ICWA's applicability to Probation
 - Probation Data & CWS/CMS challenges
 - Evidence-based practices in Probation
- **Interpret** acronyms of commonly used terms and agencies involved in Juvenile Probation, know the different types of Juvenile Probation supervision. Understand why youth are tried in Juvenile Court or in the Adult Court system.
- **Identify** common criminogenic risk factors physical and behavioral indicators and assessment tools for juvenile offenders
- **Describe** – What does a probation title IV-E reasonable candidate look like
- **Identify** - What consists of "Probation Only" activities.
- **Experience** – "A Probation Training Day"

This course will provide a framework for understanding the issues around probation youth as well as how to identify, address treatment and service needs for probation youth.

Pablo Carrillo is a retired Supervising Probation Officer who worked in County Probation for 27 years. During his tenure, he was involved in training and mentoring juvenile probation placement officers and administrators for over 10 years. His areas of expertise include out-of-home placement, case planning and management, Title IV-E, funding issues, interdisciplinary collaboration, crisis intervention, and systems of care. Carrillo is a member of the Probation Advisory Committee of the Resource Center for Family-Focused Practice.

Cathy Groh, MSW, L.C.S.W., is a CWS/CMS Specialist (Child Welfare Services/Case Management System) with the Resource Center for Family-Focused Practice at the Center for Human Services, UC Davis Extension. She previously served as a social work supervisor in a Department of Family and Children's Services, and as an emergency response social worker. In addition to her CWS/CMS expertise, Groh is experienced in crisis intervention, counseling, and development of service plans.

Cathy Roland has worked in a variety of probation department capacities since 1981, including Juvenile Placement Unit, Juvenile Day Reporting Center, Independent Living Program, School Probation Officer Unit, Training, Juvenile supervision and aftercare units, Juvenile Hall and the Regional Youth Educational Facility. She is currently the Probation Specialist at the UC Davis Extension, Resource Center for Family-Focused Practice.
